

**(READ VERY CAREFULLY BEFORE SIGNING)**

**RELEASE OF ALL LIABILITY, ACKNOWLEDGMENT OF RISK AND PERMISSION TO SWIM**

No camper will be allowed to swim during camp without parental permission, acknowledgment of risk and release of all liability.

The swimming facility at Camp Clover Point is Lake of the Ozarks.

**I acknowledge knowing the following facts:**

1. Lake of the Ozarks is a dirty, muddy lake. If my child sinks under water he/she will not be visible to anyone.  
We do not represent that the swim area is free of any hazards.
2. Florida College Missouri Summer Camp, Inc. has no licensed or trained lifeguards. None are provided by the State Park.
3. Florida College Missouri Summer Camp, Inc. will have a camp nurse but she will not be at the swimming area.
4. None of the camp counselors at Florida College Missouri Summer Camp, Inc. have current CPR training or current Lifesaving / Life guarding training or experience.
5. The camp directors specifically recommend against allowing my child to swim at camp.
6. The nearest hospital is Osage Beach, several miles from the campsite and given camp roads and resort traffic, any emergency transport from camp to the hospital may take more than an hour.
7. Camp counselors that try to watch swimmers must observe swimmers in one direction and non-swimmers and waders in the opposite direction.
8. I understand that unless the camp directors have this signed, notarized Release of All Liability, Acknowledgment of Risk and Permission to Swim form, my children will not be permitted to swim at camp.
9. I have no expectation that Florida College, Florida College Missouri Summer Camp, Inc., the directors or any of the counselors carry any liability insurance coverage for events that occur at camp.

In spite of the foregoing information my child/children \_\_\_\_\_ is/are strong, experienced swimmers that do not require supervision. I, as the father, mother, legal guardian (circle the one that applies) give specific permission for my child/children to swim under these circumstances. I further state that no one has provided me with any information about swimming that is not contained herein.

In consideration of allowing my child/children to swim at camp this year I specifically release Florida College, Lake of Ozarks State Park, Florida College Missouri Summer Camp, Inc., their directors, employees, agents and counselors of and from any and all liability, actions, claims and demands whatsoever which the undersigned and the undersigned minor child may have, on account of or arising out of personal injuries or damage to the undersign's minor child as the result of any activity associated in any way with swimming, wading or activity in or near the lake during camp.

The undersigned also agrees to indemnify and hold harmless those herein released of and from any and all claims of anyone claiming as a sibling, spouse or parent of the undersigned's child or the undersigned from any claims arising out of the afore stated activity.

The consideration herein expressed is contractual and not mere matter of recital.
